Dear New and Returning Members,

On behalf of the Park Lakes Board, we wish you all a Happy New Year. We are looking forward to a great 2010 paddle and tennis season.

It is a great time to be a Park lakes member!! The club is vibrant with several new paddle players, and with our regular members, they are generating energy and enthusiasm for the club. We now have Saturday morning scrambles and barbecuing for paddle players of all skill levels. Hopefully we can carry this over to the tennis season. Come on out and enjoy the fun and camaraderie.

The Board now has nine members with four of them just joining the board. They are bringing fresh ideas and new perspectives for the betterment of the club.

The average age of the club is decreasing with addition of new members. This is, of course, a good thing for the long term viability of our club.

We have initiated paddle lessons with our pro, Bob Nunez for all skill levels of players.

Enhanced and more frequent social activities are in place and open to all members.

The facility continues to be upgraded. In 2009 we upgraded the bathroom, provided paving for the tennis wall practice area, did some driveway paving, made repairs and maintenance of the Paddle Hut, improved the website, implemented a reciprocal agreement with the Mountain Lakes Club, and installed video cameras for security and court condition monitoring.

For 2010 we want to continue paving of the driveway, install fans under the paddle courts to improve air flow, add additional video monitors to improve security and tennis/paddle court condition monitoring, and fix Court 5 which has a chronic drainage problem.

To ensure we can meet our maintenance and facility improvement needs and provide adequate financial health for the club, the board has unanimously voted for a modest dues increase, The last increase was in 2007, three years ago. The

increase is approximately 3% - less than 1% a year. This will help ensure the club has funds to meet its needs.

As an incentive to increase our club membership and give a cost break to existing members, we are launching a Membership Incentive Drive. Any member who brings in a new member will receive a \$100 reduction in their dues (or \$100 refund if dues have already been paid), and the new member will also receive a \$100 reduction. Both run for one year. In addition, if a Single Membership upgrades to a Family Membership, they will receive a one year \$100 reduction off the Family Membership rate.

We look forward to seeing all of you on the paddle and tennis courts.
